#### PLANNING APPLICATIONS AND MATTERS

It was agreed an objection would be lodged regarding this application on the grounds of highway safety concerns and potential over-intensity of development

#### PARISH LENGTHSMAN

It was noted that the parish lengthsmen was to be asked to quote for the repair of the roof of the shelter on the Recreation Ground.

The possibility of the lengthsmen sweeping the pavements in the village was discussed but it was noted there could be a problem due to two of the roads being A roads. Lancashire Highways had previously advised that they had to deal with any maintenance issues arising adjacent to A roads.
